Working career expanded over thirty-eight years.

Rob has extensive knowledge in the workings of the Co-op system and understands what is expected as a Director having served as a Director of the North of 53 Co-op (Flin Flon) for twenty-one years, fifteen as Vice President.

Rob considers himself a good listener and a prudent person. That was evident when North of 53 Coop embarked on discussions and planning over a two year period to build a new grocery store. Rob was Vice President during this period and ensured he spoke and listened to the membership because of this massive undertaking. Naturally there was resistance from some of the membership however after final deliberation the Board, with the blessing of FCL along with some funding, proceeded in building a state of the art 40,000 sq ft grocery store to the tune of about \$17 million. This was one of the most significant commercial developments in Flin Flon history.
