## OFFICIAL CONTEST RULES & REGULATIONS

"Mid Island Co-op 13 Days of Giveaways"

The Mid Island Co-op 13 Days of Giveaways Co-op Contest (the "**Contest**") is sponsored by Mid Island Consumer Services Co-operative (the "**Sponsor**"). The Contest begins 12:00:00 a.m. (PST) on December 1st, 2021 (the "**Contest Start Date**") and ends 5:00 pm (PST) on December 13, 2021 (the "**Contest Closing Date**"), known as the "**Contest Period**".

### 1. HOW TO ENTER:

NO PURCHASE NECESSARY. A purchase will not increase your chance of winning.

There are two (2) ways to enter the Contest, as follows:

Purchase Entry Method: To enter, an Eligible Entrant must go to any Mid Island Co-op Gas Bar or Mid Island Liquor Store ("Participating Store") and enter to win by scanning the QR Code Entry Form inside the location.

Online Entry Method: To obtain one (1) Entry without going in-store, Entrant must visit [www.midislandco-op.crs](http://www.midislandco-op.crs) and enter at the bottom of the 13 Days of Giveaways website article.

All entries must be received on or before the Contest Closing Date.

### 2. ELIGIBILITY:

#### Eligible

To enter the Contest and be eligible to win the prize in the Contest, a person must be a resident of Vancouver Island and be over the age of 19 years at the time of the Contest Start Date.

#### Not Eligible

Residents outside of Vancouver Island are not eligible to enter the Contest.

The Sponsor's employees and the Sponsor's Board of Director as well as the immediate family\* and those domiciled with the Sponsor's employees and Board of Directors are not eligible to participate in the Contest or win prizes in the Contest.

Employees of the Sponsor's member retail co-operatives ("**Co-ops**"), the Co-ops' Board of Directors as well as the immediate family\* and those domiciled with the Co-ops' employees and the Co-ops' Board of Directors are not eligible to participate in the Contest or win prizes in the Contest.

Employees of the Sponsor's and the Co-ops' operators, affiliates, agents, independent judging organization, consulting, advertising and promotional agencies, as well as those domiciled with and the immediate family\* of the foregoing, are not eligible to participate in the Contest or win prizes in the Contest.

\* "Immediate family" includes parents, siblings, children and spouses.

Subject to applicable law, the Sponsor reserves the right, in its sole discretion and for any reason, to cancel, terminate, modify these Official Rules or administration of the Contest or suspend this Contest in whole or in part without prior notice and with no obligation or liability. In the Sponsor's sole discretion, a Prize Winner may be selected by randomly drawing from among all valid entries received up to the time of cancellation, termination or suspension.

By participating in the Contest, entrants agree to release and indemnify the Sponsor and any independent judging organization as well as their respective parents, affiliates, member retail co-operatives, agents and contractors, including advertising and promotional agencies, and their directors, officers and employees, from any and all losses, expenses (including legal fees), damages and claims of any kind in connection with the Contest or resulting from the acceptance,

Under no circumstances will the Sponsor, its member retail co-operatives, subsidiaries, affiliates, independent contractors, and their respective directors, officers, employees, and agents, including advertising and promotional agencies, be responsible for any injuries, loss or damages of any kind (compensatory, direct, incidental, indirect, consequential or otherwise) with respect to or in any way arising from, this Contest or the prize awarded. In no event shall the Sponsor be required to award more prizes than what is indicated in these Official Rules or award the prizes otherwise than in accordance with these Official Rules.

### 6. PRIVACY:

The Sponsor, Mid Island Consumer Services Co-operative, respects your right to privacy. Personal information collected is not sold, rented or loaned to any third parties.

The Sponsor will use the information collected solely to administer the Contest. No correspondence will be entered into except with selected entrants.

Mid Island Consumer Services Co-operative will handle personal information in accordance with its privacy policies and practices, which can be accessed on its website or by contacting Mid Island Co-op Administrative Office and in accordance with applicable laws. By completing and submitting a Contest entry form you consent to the collection use and disclosure of your personal information for the purposes stated herein.
